 I understand that: The amount I agreed to above will be automatically deducted from my EBT account on the date that I receive SNAP benefits. I will receive farm produce either weekly or biweekly (dependent on my share choice), which will be availated up at Quabbin Harvest, 12 North Main Street in Orange. Please check one of the following pick up days: To 3:30 p.m. – 7:00 p.m. OR Wednesdays, 10:00 a.m. – 7:00 p.m. It is my responsibility to pick up my share on my scheduled pick-update, during the scheduled pick-up time If I cannot pick up my share, it is my responsibility to have someone pick it up for me. If I do not pick up my share during my scheduled pick-up time, it will be donated to a local food pantry, she other institution that will make use of the produce and I will not get a refund. The types of produce in my share will change weekly. There is no guarantee on the exact amount of produce will vary in weight, size, and type of produce. I cannot return my CSA Share for a refund or exchange it for other produce. I can cancel my participation in the pilot at any time. If I no longer want to participate, I will ask Quabbin H or call DTA for a cancellation form. I will complete and return the form to Quabbin Harvest CSA at least 10 days before I receive my next mont benefit. If I do not return the completed form at least 10 days before that date, my CSA Share payment may automated deducted from my next SNAP benefit. In that case, the cancellation will take effect the following month. I understand that Quabbin Harvest CSA and DTA will act on my request to cancel my payment as soon as position of the complete in a brief survey about this SNAP CSA Pilot at the beginning and end of the CSA sease. My copy of this agreement, and the notices I will receive each time a payment is deducted from my SNAP I account, will serve as receipt of payment. 	ble for pick resdays, lter, or e.
